



Mooragh Park (Public Right of Way 453, Ramsey) Cycle-Path Designation Order 2021

The Department of Infrastructure is proposing to make an order, **Mooragh Park (Public Right of Way No. 453, Ramsey) Cycle-Path Designation Order 2021,** under Section 91a of the Highways Act 1986, the effect of which will be to designate the footpath, made up of the existing Public Right of Way No 453, to a cycle-path.

Public Right of Way No. 453 runs from the back of the footway on Bay View to the back of the footway on Grove Mount for a length of approximately 168 metres. The PROW is currently designated as a footpath. If the Order is approved this designation will change to a cycle-path.

In order for the Department of Infrastructure to designate a footpath as a cycle-path the legislation, as set out in the Highways Act 1986, must be adhered to. The legislation states that notice must be served on the owner, lessee and occupier of the land affected. Notice must also be published in a local newspaper, in this instance The Courier.

Enclosed is a copy of the proposed order. Please could you make this copy available to members of the public, who may wish to view the proposed order at your offices. The notice runs from Friday 02 July 2021 until Friday 30 July 2021.

Laid before Tynwald¹: Coming into operation:

The Department of Infrastructure, after complying with the requirements of paragraph 1 of Schedule 2 to the Road Traffic Regulation Act 1985², makes the following Order under section 91A(1) of the Highways Act 1986.

1 Title

This Order is the Mooragh Park (Public Right of Way 453, Ramsey) Cycle-Path Designation Order 2021.

2 Commencement

This Order comes into operation on xxx.

3 Designation of footpath to cycle-path

- (1) The footpath made up of the existing public rights of way referred to in Schedule 1 is designated as a cycle-path.
- (2) The footpath as designated by paragraph (1) is as shown by a bold purple line on the map in Schedule 2.


