(8) The book kept under subsection (7) shall at all reasonable hours be open to the inspection of —

(a) any local government elector for the district of the authority or, in the case of a joint committee, the district of any of the constituent authorities, and

(b) any person authorised for the purpose by the Department, and any such elector or authorised person may make a copy of or extract from the book.

Any suspension of standing Orders is recorded in the minutes of the relevant meeting and recorded in this register.
