
Introduction

The Ramsey Town Commissioners request the approval of the Department of Infrastructure under Section 25 of the Local Government Act 1985 to grant an underground services easement for electricity cable to the rear of the property "Peveril Court" also known as "Bleak House" Mooragh Promenade, Ramey, under land in the Commission's ownership, being the "Peveril Plot," abutting Hope Street and Old River Road.

Detail

Manx Utilities, of PO Box 177 Douglas IM99 1PS have sought the Commission's agreement, by way of a wayleave, to install an electricity cable pipe under land in the Commissioners' ownership being part of the area of land known as "The Peveril Plot".

The property has been in a ruinous condition for many years and the prospective owner wishes to have an electricity supply installed not least to ensure a supply of current during renovation works.

Consideration

The Commission has sought the advice of Manx Utilities who advise that the easement value is £25 (Twenty-Five Pounds) being that the length of easement is under 10 metres, plus the cost of making good and all other costs incurred. The landowner has agreed to meet this cost plus the Commissioners reasonable legal costs.

Planning

There is no planning requirement for the location of cables and underground services.

Land Ownership

The land under which the easement is sought is in the ownership of the Ramsey Town Commissioners.
