Introduction

The Ramsey Town Commissioners request the approval of the Department of Infrastructure under Section 25 of the Local Government Act 1985 to grant authority to enter into an Agreement with Manx Telecom for the siting, inspecting, repair or alteration, removal or addition of further cables of 5 Poles on land in the ownership of the Commissioners as hereunder:

Adjacent to the footpath at the rear of No. 10 Bircham Avenue Close Adjacent to the footpath at the rear of No. 23 Bircham Avenue Close On the footway at the rear of 63/64 Bircham Avenue Close On the corner of car park at the rear of 49/50 Bircham Avenue Close On the grass area near an existing Lamp Post at the rear of 6/7 Close Caarjys

Detail

Manx Telecom Trading Limited of Isle of Man Business Park, Cooil Road, Braddan, Isle of Man, IM99 1HX (Incorporated in the Isle of Man with company registration number 005629V) have sought the Commission's agreement, by way of a wayleave (reference No. MTA 165A) to enter into an Agreement to place and keep thereon 5 Telecom Poles on land in the Commissioners' ownership in the vicinity of Bircham Avenue Close, Close Caarjys and Gladstone Avenue.

The agreement is framed by Manx Telecom Limited in terms of Schedule 1 to the Telecommunications Act 1984 (as amended).

Consideration

The Commission propose to permit the wayleave for £848.75 (£11.33 per pole for the 15-year life of the pole). The Company will repair any damage sustained in the erection of the poles to the Commissioners reasonable satisfaction and will indemnify the Commissioners for a sum up to £1,000,000 against any claim made against them as a result of the installation or keeping of the poles on the Commissioners' land.

Planning

Manx Telecom are responsible for the appropriate approvals; ensuring that the poles are installed accordingly to any permitted development order.
