LED Lighting Initiative

Good News ! The LED Lighting Initiative which was launched by the Department of Environment, Food and Agriculture (DEFA) and supported by Manx Utilities, are again assisting low income households to reduce their energy usage with provision of LED lights at no cost to eligible households.

To be eligible to receive up to 10 LED bulbs, a member of the household must satisfy at least one of the following criteria:

- Employed person's allowance
- ٠ fit
- Manx Utilities priority care register
- **Recipient of Food Bank resources** •
- Recipient of Town/Village 'Coal Fund' resources at Christmas
- afford new light bulbs
- Recipient of financial advice from Office of Fair Trading; .
- Occupant aged 75 or more. •

Lightbulbs are available from Ramsey Town Library.

Condensation.

Condensation is always a problem during the winter months, dampness is a condition that affects millions of homes. The problem can lead to staining and mould growth and damaging wallpaper, wall surfaces, window

frames, furniture and clothing. It is this that the tenant sees first, and it gives an indication of the potential scale of the problem. All air contains a certain amount of 'invisible' water vapour. The higher the temperature of the air the more water vapour it can hold.

Areas particularly prone are:-

- Kitchens and bathrooms.
- Walls of unheated rooms.
- Cold corners of rooms.
- Wardrobes/cupboards and behind furniture against an outside wall.

Condensation can be avoided by basic lifestyle actions.

Ramsey Town Commissioners are working hard to improve our properties which include:-

- External Refurbishment of 50x domestic Properties at Cronk Elfin Re-roofing & external render system along with Bathroom refurbishment - Currently ongoing & due for completion March 2024.
- Fencing and landscaping works to 22x properties at Close Caariys Due for completion October 2022.
- Central Heating Boiler replacement program to properties at Bircham Avenue Close Ongoing & ٠ due for completion February 2023.
- Replacement windows to 16x domestic properties at Gladstone Avenue Currently at Tender stage, due to commence January 2023.
- Replacement windows to 10x domestic properties at Vernon Road Currently at Tender stage, ٠ due to commence January 2023.
- Replacement Pedestrian Footpaths to frontage of 10x domestic properties at Vernon Road -٠ Currently at Tender stage, due to commence January 2023.
- Former Close Woirrey Housing complex Due for demolition early 2023, currently under design and projected for build stage mid-2024.

Property Inspections.

We are continuing to carry out property inspections to all our properties and are still finding a number of properties have either removed their smoke detector or have not replaced the battery. May we remind all tenants that this practice is unsafe and is a breach of their tenancy to alter or remove smoke detectors. All of our properties will have a smoke alarm fitted. These should be tested every week by pressing the test button.

If you are struggling to change your battery, please let us know and we can help. If your home does not have a working smoke alarm or you believe the smoke alarm may be faulty, please contact the Housing Department immediately on 810100.

If you find that your meter box door is broken, please can we ask that you report this to the service provider direct.
